PUBLIC HEARING MINUTES, TUESDAY, APRIL 29, 2014**

MINUTES OF THE PUBLIC HEARING ON THE BUDGET of the Board of Education of the Borough of Beach Haven, County of Ocean, State of New Jersey held on Tuesday, April 29, 2014.
