### GOVERNANCE:

1. Approve Resolution Asking for Action of NJSEHBP Rate Increase:

**WHEREAS,** The **Beach Haven School District** is currently a member of the New Jersey State Education Health Benefits Plan; and

WHEREAS, Chapter 44, P.L. 2020 mandated certain plans for the employees of school districts in the State of New Jersey without input from the School Districts that have to pay for those plans; and

**WHEREAS,** in certain cases there is a separate contribution guide attached to Chapter 44, P.L. 2020 and the plans created by that statute that created an additional cost to the districts in the State of New Jersey; and

WHEREAS, the Beach Haven Board of Education is responsible for the tax levy imposed on the taxpayers of the Southern Regional School District; and

**WHEREAS**, the State of New Jersey's actuary, AON presented a rate renewal on July 13, 2022 that proposed a 15.1% increase in health insurance premiums; and

**WHEREAS**, the rate report stated that there was an increase of urgent care and emergency room utilization in the experience period used to determine the 15.1% increase; and

**WHEREAS**, the 15.1% increase will have a devastating impact on both the taxpayers and employees of the **Beach Haven School District**; and

WHEREAS, the utilization of emergency rooms and urgent care is directly attributed to COVID claims; and

**WHEREAS**, the rate renewal report references a 3.4% anticipated savings that was to occur due to a Navigation and Advocacy program that the state awarded a contract to Horizon to administer; and

**WHEREAS**, that navigation and advocacy program is the subject of an open CCAU complaint that the Division of Treasury has not yet adjudicated; and

WHEREAS, contracts between the state's third party administrator and providers are not transparent, and

WHEREAS, the State currently has one third party administrator for active and early retirees; and

WHEREAS, that contract is set to expire on December 31, 2022 unless extended by the State; and

**WHEREAS**, the State has not started the bidding process and will most likely extend the contract while the CCAU complaint is still open;

**NOW THEREFORE BE IT RESOLVED;** that the **Beach Haven Board of Education** requests the State of New Jersey to immediately take action on the following:

1. Utilize some of the \$1.6 Billion in federal COVID aid that has not been assigned to defray the costs in the rate renewal report that are attributed to the pandemic.

2. Immediately adjudicate the open CCAU complaint against Horizon

3. Refrain from extending the current contract with Horizon and put the third party administrator contract out to open competitive bidding and award at least two vendors the contract.
