

# New Student Registration 2020/2021

## **Entrance Requirements:**

All children entering Beach Haven School's Kindergarten Program in September, 2020 must meet the following requirements:

- **Kindergarten only** - The child must be 5 years old on or before **October 1, 2020**.
- **Preschool students** - Must have received confirmation of acceptance.
- The child's birth date must be documented by an original birth certificate.
- A current physical examination, performed during the last 365 days, is required for all kindergarten students.
- Two proofs of residency that you live within the Beach Haven District must be presented.
- Proof of required immunization.

## **There are Two Steps to the Registration Process**

### **Step 1: Registration Packet:**

- Print or fill out registration packet and complete in its entirety

- If you are unable to scan or email the packet, mail it to 8<sup>th</sup> Street and Beach Ave, Beach Haven, NJ 08008

### **Step 2: Document Verification**

#### **These documents must be verified in person:**

An original birth certificate with parents' names and raised seal.

Registration Affidavit - must be signed in front of registration official once residency is verified

## New Student Registration 2020/2021

- Two proofs of residency, one of which must be a copy of tax bill, agreement of sale or lease, plus utility bills, statements, etc...
- A physical examination, performed during the last 365 days, is required for all kindergarten students
- Proof of immunization: see list below for required immunizations

Listed below is the minimum required number of immunization doses your child must have to enroll/attend **Preschool**

### Pre-school Requirements for 3 and 4 year old's

Diphtheria, tetanus & acellular pertussis (DTaP)	4 doses
Inactivated Poliovirus (Polio)	3 doses
Haemophilus influenzae type b (Hib)	At least 1 dose given on or after the first birthday
Pneumococcal conjugate (PCV 13)	At least 1 dose given on or after the first birthday
Measles, mumps, rubella (MMR)	1 dose
Varicella (VAR)	1 dose given on or after the first birthday
Influenza (IIV; LAIV)	One dose due each year up until the age of 5

# New Student Registration 2020/2021

## Kindergarten Requirements

Listed in the chart below is the minimum required number of immunization doses your child must have to enroll/attend in Kindergarten.

Immunization	Doses	Exceptions & Exemptions
<b>DTap</b> <b>Diphtheria, Tetanus,</b> <b>acellular Pertussis</b>	4 doses with 1 dose given on or after the 4 <sup>th</sup> birthday <b><u>OR</u></b> any 5 doses	NJ accepts valid medical and religious exemptions.
<b>IPV</b> <b>Inactivated Polio Vaccine</b>	3 doses with 1 dose given on or after the 4 <sup>th</sup> birthday <b><u>OR</u></b> any 4 doses	NJ accepts valid medical and religious exemptions.
<b>MMR</b> <b>Measles, Mumps, Rubella</b>	2 doses of MMR <b><u>OR</u></b> 2 doses of measles 1 dose of mumps and 1 dose of rubella	MMR exemption is granted with serologic evidence of immunity to MMR, in lieu of the second MMR vaccine is accepted. NJ accepts valid medical and religious exemptions.
<b>Hepatitis B</b>	3 doses	NJ accepts valid medical and religious exemptions.
<b>Chicken Pox</b> <b>Varicella</b>	1 dose	A child will not have to receive the varicella vaccine with the provision of the following: 1) Documented laboratory evidence showing immunity 2) A physician's written statement that the child previously had chickenpox, 3) A parent's written statement that the child previously had chickenpox. NJ accepts valid medical and religious exemptions.
